Membership......Karen St. Hilaire, Chairperson

I would like to Thank the District Presidents, District Vice Presidents, County Membership Chairs and especially the Unit Membership Chairs for the excellent job and teamwork you did to assist the Department of New York in reaching 91.81% goal of members paid. We are getting closer to reaching our one hundred percent goal, for President Nancy. Let's reach out to those last few members who have not paid. They may just need a gentle reminder, or they may also need some extra help. Also continue to recruit, set up membership table with information and applications at all your Post and community events. Poppy distribution days are coming up, what a great way to educate the community about what the Poppy means to our Veterans and recruit new members.

On the National level Eastern Division (which includes the Department of New York) slid from second to third place by a few tenths of a percent. Hopefully, we can climb back up and take over first place.

Milestone # 4 was for units that reached 100% by March 11- there were seventy-six units entered into the drawing. The following five units were drawn and will receive a check for \$50.00: #317 Skaneateles Falls, #1285 Bayville, # 1688 Laurens, #521 Montgomery, and #66 Camden. Congratulations to the following Counties Seneca 106.42%, Livingston 101.51%, Schuyler 100.66%, and Fulton 100.41% paid membership.

At Mid-Winter we held a presentation on ALAMIS (American Legion Auxiliary Information System) an online tool to assist Units with submitting renewals and new applications and to have the ability to update your unit members data, like name or address changes and so forth. We also presented to the District and County membership chair as a read only. We had the understanding that they would ALAMIS be allowed to view units in their county or district ALAMIS only.

It was brought to the attention of the Department officers that the District and County users have Departmental View, meaning they have access to all members of the Department of New York, including personal information. The Department office reached out to the National office, whose response was yes anyone with District or County ALAMIS could access the entire Department of New York. It was discussed by members at the April Department of New York Executive meeting, as there was a concern about maintaining members privacy, therefore a motion was made and passed: That the Department of New York **will no longer allow District or County ALAMIS access**. Those that currently have District or County access will not be renewed and no new applications will be accepted. This **DOES NOT AFFECT UNIT ALAMIS FULL**, since the member who has this access can only view his/her unit members. To obtain ALAMIS Unit Access Read, Write or Full you must fill out the form and send it with check to the Department Office. All forms can be found on the Department Website under the Membership Committee.

 National pulled rosters and 2024 membership cards. This means that any changes, new members, rejoins and transfers made after April 1st will not be reflected on the Unit's 2024 membership cards and rosters. This does NOT mean we will stop accepting 2023 dues. We process renewals/new members ALL year; please do not hold onto it until the Fall. If a member's dues was not paid for 2023, 2022 they are now considered expired for 2024 rosters and will not appear on the 2024 roster and will not have a printed membership card. When paying their dues, you will have to give them a handwritten card for 2024.

- The 2024 Unit Data form for renewal notices were mailed to Unit Presidents in early March. It is available as a fillable PDF to download off of our website under the membership tab. Make sure you are using the 2024 form only. Please complete the entire form and do not leave anything blank. This form is due back to the Department Office no later than <u>May</u> <u>1st, 2023</u>. Please remember that the new rates will take effect with the 2024 dues that will be available to pay July 2023. If your current rate is not sufficient, please make sure your unit notifies all members that there will be dues increase proposed for the unit, when the meeting will be held, etc. Please make sure you follow your unit Constitution & Bylaws regarding notice to all members.
- The 2024 per capita for Department and National for senior members is \$28; the junior per capita is staying the same at \$6.25. If you do not submit your form by May 1st, 2023 and your current rate is below the amounts above, the Unit will not receive a portion of the per capita for 2024. Once the rates are locked and they need to be changed, National will charge a processing fee.
- At this time, the current year (2023) dues have to be paid first before back dues. This now includes 2022 dues.
- Please do not send DD214's/active-duty documentation into the office with applications. Once the Post Adjutant/Officer signs the application and the membership chair (ALA) verifies all supporting documents, returns the supporting documents to the member. The office only needs the completed – signed application with the dues and transmittal. Remember – if the veteran is living, he/she must be a current paid member in the American Legion. Remember to check which era the veteran served and the relationship of the veteran to the ALA applicant. Please circle the appropriate relationship to the veteran.
- Applications need to be complete and legible otherwise they will be returned to the unit membership chair. New members' address needs to be complete. No abbreviations on city/town. All membership applications must be presented to the unit membership chairman with the proper documentation prior to being submitted to the office for processing.
- Membership chairs if your unit members move, change any contact information, phone numbers, emails, etc., please send the change to the Department office or if you have unit write or unit full, please make the appropriate changes so the information is updated in a timely manner. This also pertains to unit President, Membership Chair and Unit Treasurer.

I was looking at the Walk-A-Thon Facebook page group called Walk-A-Thon NYS. Wow! A lot of walks are being planned around New York. I also see the *BOOTS* being downloaded for use. Please post photos of your walks on our Department Facebook and the Walk-A-Thon Facebook pages. Fun pics can be taken of everyone and any fancy footwear or people with their Boot they paid a donation for. I cannot wait to see all the fun we had.

I was honored to represent NY at the Washington, DC Conference at the end of February. We discussed the PACT Act and the Camp Lejeune Water Contamination Lawsuit. We had a presentation from the law firm Bergmann & Moore, LLC who has a Memorandum of Understanding (MOU) with The American Legion to help Legionnaires understand the Camp

Lejeune Justice Act (CLJA). A full page of the Frequently Asked Questions (FAQs) printed in the Legion magazine should also be coming to the Auxiliary magazine. We hope to inform the widows / widowers / children of veterans who have passed away; they may also be eligible for claims.

Also, we discussed those bad actors who send all the spam emails, spam ads online, spam text messages, and even checks in the mail trying to take advantage of our veterans and their families during a time of need. Unfortunately, there are criminals out there who will take advantage of anyone so BEWARE. Do not cash any checks from anyone in the mail that you did not hire on your behalf – this is also a trick.

DO read any fine print.

DO speak with an accredited Service Officer or reputable law firm.

DO look into hiring reputable law firms to represent you in your claims for these funds.

Remember that none of us know all there is about these subjects, so don't be afraid to ask for help.

We will be needing volunteers for the Medical Centers again soon. The VAVS Representatives and Deputies are reporting that some of the VAMC opportunities are coming back. What "big ticket" items does your veteran community need? Furnishings for a veterans transitional housing facility? Does the VAMC or the New York State Veterans Home in your area need new recreation equipment, such as bingo blower machines and flashboards? Or large equipment for art therapy, such as a chromatic Tone Chime set or a hand bell set? Or new patio furniture? These items often are not covered by the facility's budget, so they turn to the volunteer community. The American Legion Auxiliary Foundation (ALAF) Veteran Projects Fund can help!! Your Unit, County, or District can apply for a grant, which will typically cover up to 80% of the cost. For example, the cost of furnishing a bedroom for a veterans transitional housing facility is approximately \$500 – your Unit would need to raise only \$100! Apply for a grant. It's a 3-page application, which can be completed online. Your 20% can come from poppy funds, as all these items contribute to the rehabilitation of veterans. Need more information before you apply? Constitution and Bylaws/Resolutions......Sally Johnston, Chairperson

IMPORTANT SUBMISSION CHANGE

As of Department Executive meeting held April 1-2, 2023, there has been much discussion as to how Units need to forward their Constitution & Bylaws / Standing Rules to this chairman.

In an effort to further simplify submission of "Standing Rules ONLY" the department has enhanced the form to include a space for the Unit name, number, and contact information. There is also a line that states "Unit approved date." Additionally, there are 2 signature lines, one for the President and one for the Secretary.

At the very bottom of the page, there will be a space for me as the chairman to sign and date if submission is being forwarded to the department office as "reviewed." Otherwise, I will be contacting the person whose information is noted on the "Transmittal Sheet."

Very important – when filling out Standing Rules 1 (Sr. dues) and 2 (Jr. dues) you have the choice to state **"per capita"** which means the dollar amount per member that is forwarded to the department, **"plus the number of dollars"** the Unit wishes to keep in their treasury. For example: 2024 Sr. dues, "per capita" is \$28.00. If the Unit wanted to collect \$30.00 / member, then the Standing Rules #1 would read, **"per capita plus \$2.00"**. By stating the words "per capita" plus **"x"** number of dollars, the Standing Rules would not have to be changed every time there is dues increase at the national and/or department level. However, if the Unit chooses to insert the actual dollar amount (ex. \$30.00), then the Unit would be required to change their Standing Rules accordingly to be in compliance.

June 1st is the last day I will be accepting any submissions for Constitution & Bylaws(C&B) / Standing Rules. Should I receive submissions that need to be returned for corrections, hopefully this will give both parties time enough to clean up any loose ends.

I have a backlog of submissions that I have sent emails with no return responses. I utilized the contact information provided on the Transmittal Sheet. If I don't get responses, then I will be returning them to the sender which is very costly on everyone's part.

To recap: If you are changing your Constitution & Bylaws and Standing Rules, you will need to submit the entire packet to me. Transmittal sheet, 2 copies of the "new submission" along with Standing Rules. Remember, to "sign and include the Unit approval date" on the first page of the C&B. If you are changing your Standing Rules, please begin with #3, if the Unit is submitting other changes than dues.

If you are submitting Standing Rules Only, follow the procedure as mentioned above. As a gentle reminder, I try to answer all emails within a reasonable length of time. Also, you may contact me by phone, text, or leave a message. However, I do go to the department office every 2 -3 weeks to copy and mail submissions. Thank you in advance for your cooperation as we are coming to the close of this administrative year. I know this year we have faced many challenges, but we are all learning together to get the job done to the best of our ability.

Education.....AnneBaglio, Chairperson

How many Units out there in Dept. of NY did anything for the schools or children in the schools this year (2022-2023)? Did any Units buy school supplies, ex. pens, pencils, rulers, books, backpacks? promote scholarships? Give out scholarships last year (May or June 2022)? Collect box tops? I have heard from some Units. We really need these reports. Please either send them to your County Education Chairman who will forward to me or include me on the email also via w/ report form. I know everyone works hard at volunteering and it should be reported. Also, if there is a Unit or member that did something outstanding for Education we have awards, also I would love this information for the Year-end report to National with pictures if you have them. Please look in the POC book for the awards under Education or give me a call 716-432-1354, or email nyaleducation@gmail.com and we can discuss what you need.

We are very excited about this 82nd Session of ALA Empire Girls State. We have worked hard to implement changes based on the feedback from citizens and staff of last year's session. We have adjusted the schedule, providing guidance on when work (such as bill writing, campaigning and speech writing and Learning Logs) is to be completed, added informational sessions expanding on the topics we have historically included such as the American Legion Auxiliary, Americanism, public policy, the political process, and women in leadership. We are busy recruiting guest speakers and welcome your referrals. We have changed the format of the Thursday evening Fun Night to an informal gathering with focus on a service project and social networking to encourage continued involvement in the ALA after Girls State. Changes made to registration materials and the agreements that citizens sign during registration were designed to fully inform citizens about the program and clearly outline the expectations of their participation. No citizen should arrive without a clear expectation of what the program is, and what will be expected of them. Please encourage your candidates to not only read what they are signing but explore the program information on our website prior to arrival.

In addition, our citizen manual has undergone a complete revision this year. We have also reformatted the Learning Log which is a component of the program. It is designed to help them process the experiences they have while at ALA EGS. It is a powerful practice to honestly and thoughtfully reflect on learning and experiences, and the Learning Log will be a great reminder of not just the program, but of their own personal growth throughout the week. It will also help them to frame their thinking in positive and proactive ways as the week unfolds. The Learning Log entries are designed to assist them when preparing reports to their sponsoring units and counties, as well as the optional college credit opportunity.

We are currently still looking for 2 nurses or EMTs but are otherwise fully staffed. We have instituted a pre-session training schedule using zoom. Staff meet once a month from March to June via zoom to conduct training sessions leading up to our Friday evening and all-day Saturday in-person staff training. This includes Diversity, Equity, and Inclusion training. Our DEI trainer will also be in person as a guest speaker for citizens on Monday of session.

Claire is busy processing applications and following up with unit and county ALA Girls State Chairmen and families regarding missing information. Please get transmittal forms and materials to Claire as soon as possible if you have not already done so. Extra T-shirt order forms and payment are to be sent to Kris by June 1st. Over the next few weeks Kris and Terri will be contacting counties on the waitlist regarding the availability of spots as the roster begins to populate.

Now is a good time for your Unit and County to consider supporting the ALA EGS program as a Booster or with a Booster Ad or by purchasing an item from our Amazon Wish List (search wish list: **ALA EGS '23 Wish List**). All these funds help offset the expenses of the program.

We will be conducting Virtual Orientations in May and June. All information will be emailed directly to citizens, alternates, and parents. Unit and county chairmen are welcome to attend as well.

As a reminder, citizens arrive on Sunday, July 2nd and depart on Saturday, July 8th. Please ensure that any citizens departing by bus have contact information for the bus chaperone and know their pickup time. The State of the State ceremony will be held on July 7th at 8:00pm at the SERC Field house on the Brockport campus. We would like to invite you to attend.

We would like to thank President Nancy for her abundant support, recruiting, and guidance during this time of preparation.

As this is the final newsletter for this administrative year, let me take a moment to remind units to do a quick financial "checkup" for your unit. Have you paid out all your budgeted items to your county, district, or department? Have your Audit Committee fill out the "Unit Audit Data Form" in the Plan of Action or on the Department website and mail it back to the Department Office once completed.

Have your unit fundraising efforts been as successful as you planned? If not, now is the time to start thinking about change.

Finally, has your unit addressed the dues increase for the 2024 membership year. Please remember that Senior dues per capita are \$28.00 and Junior dues per capita are \$6.25 to Department. If your unit raised the dues, please make sure that it was voted on by the unit membership and that you fill out your "Blue form" and mail that back to the Department office no later than May 1, 2023. Failure to do so may result in the incorrect dues on renewal notices. If the unit has to change the dues amount after May 1, 2023, National charges a fee for that.

Start preparing the budgets for 2023-2024 administrative year and welcome change so that we can continue to keep this great organization growing strong and continue our mission, of "Service Not Self" for our Veterans, their families, children and youth and our communities.

I love reading about all of the wonderful activities our Juniors are participating in and the service they are providing to our veterans, military, and their families! I have also received reports on the Patch Program—thank you to those Juniors who have worked hard to earn your Patches.

Did you know ALA Juniors can have their own access to the MyAuxiliary Member Portal? All they need to do is access a browser and have their member number to set up their username at www.ALAforVeterans.org. This would enable them to access ALA Academy courses, download the Junior Patch Program and ALA coloring books and so much more!

The American Legion Auxiliary encourages young women to lead the way in continuing its legacy of serving veterans, the military, and their families. Please remember, you are a mentor, and Juniors are our future as they hopefully continue their ALA membership into adulthood! MEMBER AWARD: Unit Member of the Year

Boost Troops Housing costs – Lawmakers Rep. Marilyn Strickland and Sen. Raphael Warnock want the Pentagon to pay 100 percent for all of the Basic Allowance for Housing for servicemembers instead of only 95 percent. Service members are increasingly being priced out of options to live near their bases, putting strain on our military families. When troops have to pay 5 percent, in most cases it means paying \$200 or more per month. A survey of servicemembers released recently by Blue Star Families, a support and research group. Defense Secretary Lloyd J. Austin III has expressed sympathy and will review the issue to do everything they can to relieve the stress off the families and our troops.

Repeal of the authorizations for use of military force against Iraq - S.316

On March 29, the Senate passed by Yea-Nay vote 66 - 30 to formally end the Gulf and Iraq wars. Senates Todd Young, R-Ind and Tim Kaine, D-VA both expressed in their remarks that the reason for the repeal is because the enemy who we declared war against in '91 and '02 is no more and for Congress to uphold "our most fundamental responsibility as federal legislatures to oversee the authorization of force, the conduct of military operations and ultimately oversee the circumstance under which we bring the men and women" into combat. The bill now heads to the House for a vote.

The American Legion Legislative Agenda for the 118th Congress, 1st Session:

Support our Afghan Allies = Grant the Afghan allies' permanent legal status and improve the special immigrant Visa process.

Military Quality of Life = Pass legislation to increase access to childcare for military families, food security and funding for renovating military housing.

Pay the Coast Guard = Pass legislation to guarantee Coast Guard personnel their pay without delay.

Protect the American Flag = Urge Congress to approve an amendment to the U.S. Constitution that would allow Congress to prohibit the physical desecration of the U.S. flag.

Mental Health & Suicide Prevention = Suicide rate is nearly double that of their civilian counterparts with more than 6,000 veterans taking their lives annually. Urging Congress to enhance access to alternative therapies, fund VA's suicide prevention outreach budget and invest in mental health research.

VA Healthcare Modernization = Modernizing electronic health records and a transparent online scheduling system are essential to ensure veterans receive the care they deserve.

PACT Act: Implementation & Oversight = Passage of the PACT ACT ensured millions of toxic exposed veterans to have access to healthcare and compensation. Congress needs to provide necessary oversight and funding to ensure the resources to properly implement this legislation.

Protect Veterans from Predatory Actors = oppose legislation that elevates the standing of unaccredited claims companies or legitimizes predatory practices that target veterans.

Concurrent Receipt = End unfair policy deduction of VA compensation from their DoD retirement pay.

Guard & Reserve GI Bill Parity = Urge Congress to recognize the service of National Guard and Reserve servicemembers as eligible for the GI Bill.

GI Bill for Honorable Service = Amend U.S. Code to allow access to VA educational assistance to veterans with general under honorable conditions discharges.

Adopt-a-Platoon Program is active with 3 Counties that have Units who regularly send care packages to deployed troops; and another 3 Units are actively sending care packages specifically to female soldiers.

Only 7 Counties reported clipping **coupons**; some send the coupons to a "hub, others send coupons directly to Posts in the United States and overseas.

4 Counties reported attending **Welcome Home** activities for troops returning from deployment. And another 4 Counties reported making and distributing "Yellow Ribbon Reintegration Program".

First Responders and Emergency Preparedness:

Several Counties reported that Units are involved in recognizing their local **First Responders** and are involved with and attending **Blood Drives** in their Community, but unfortunately the number of volunteers and hours was not reported.

Units have been very busy getting the word out about our great organization. This last reporting period I received reports of 13 County/Unit Newsletters, 3 flyers, 10 Post newsletters, 4 E-bulletins, 30 plus newspaper clippings, 109 articles written with one being for President Nancy's Project for Honor flight. 105 print ads, 101 pictures reported, 25 letters written, 35 Facebook pages, 21 websites and 7 interviews. There was also 1 hour and 30 minutes of radio time, 1 hour and 10 minutes of TV time and 981 hours of social media time. Volunteer hours reported were 397 totaling in value of \$11,890.15.

Warrior Family Assistance...... Charlene Mayville, Chairperson

We have finished our last reporting period for this year! Although fewer counties reported this time (32 of 62 = 51.6% vs. 67.7% in November), we had much more activity! Several Units held fundraisers for the Warrior Family Assistance Program bringing in over \$3300 to use for their local veterans! Units were also more active in publicizing the program, distributing information to the community, Post Homes, and veterans' groups. Total hours reported were 452 (\$13,537.40), donations \$1500, monetary donations directly to needy veterans \$1740, and value of goods/services donated to applicants \$3735. Great job!

Unfortunately (or not), we have had no more grant applications. From the reporting, it is apparent that units are providing for needy veterans from their own funds and providing such things as holiday gifts, paying electric bills, and basically doing a WFA program within their local area. This is excellent work in providing for our veterans!

As a reminder, there are still a few weeks to be eligible for the Linda Moseman Award for the largest single donation to the Warriors Family Assistance Program by May 1st. Look forward to seeing everyone at the Department Convention. WFA information will be available to start out the next year for incoming officers and members.
