The IRS regulation concerning auxiliaries to veteran service organizations states in part: "At least 75 percent of its members are veterans, spouses of veterans, or related to a veteran within two degrees of consanguinity (i.e., grandparent, brother, sister, grandchild represent the most distant allowable relationships)."

I know there are members who say their dues isn't due until December 31 st, but remind them that it needs to be processed by then; not just given to you on that day; especially if they want to vote at meetings in 2024.

I also ask you to look at the weekly Membership reports (either by email or from the Department website) and concentrate on those Units which are ZERO paid Units. Please find out why they haven't processed membership and work to correct it. Does hat Chairman need help?

Department President Karen's project is Hope For the Warriors. Hope was established in 2006 by spouses of veterans who witnessed, firsthand, the effects war imparts on service members and their families. Many returned with physical injuries and mental distress.

Hope For The Warriors is now a national nonprofit dedicated to restoring stability, strength, and community to military families. For over 17 years, HOPE has served the post-9/11 military community; including, service members, veterans, military families, caregivers, and families of the fallen across the country in all branches of service. Since its inception, HOPE has served over 159,000 service members, veterans, and military families through its programs.

Stability Programs and Services: focuses on financial wellness and career & educational support for service members and their family.

Strength Programs and Services: emphasizes physical and emotional wellness through clinical support services and sports and recreation opportunities.

Community Programs and Services: builds communities through connection and belonging with peer-to-peer (veteran-to-veteran or veteran-to-service member) engagement and mentorship. In 2022, they also established suicide risk screening for every veteran who contacts them.

Hope For The Warriors® has received a 4-star rating from Charity Navigator for 12 consecutive years, an honor earned by only 1% of rated charities.

AEF pins are distributed quarterly directly to the individual meeting the eligible donation level of \$100 or more

Finance.... Mary Anne Casadei, Chairperson. Members Patricia Hennessy & Marie Mock

Last time we talked about preparing a budget. This time we are going to talk about planning for your Audit.

First, is your Unit/County keeping proper records of all Transactions? Are all accounts approved by the Exec. Committee and or voting body?

Hopefully you have prepared your annual budget and it was approved by your voting body to cover both income and expenditures.

Postal Receipts: It is recommended all mail be opened in the presence of 2 people. Checks and cash should be recorded immediately. All entries should be verified by someone other than the person making the entry. Banking: Make sure receipts are banked promptly and regularly, at least weekly. All incoming money should be banked and not held over for petty cash. All accounts should be in the Unit/County name not in an individual's name. Receipts should be issued for all money collected.

Expenditures: All expenditures should be properly authorized. Supporting documentation (receipts, etc.) should be required and maintained for all expenditures. Check books should be kept in a secure, safe place. Purchases: Invoices should be checked against orders. An inventory of stock should be taken regularly. Payment should be made promptly, and match the original invoice. Orders should be placed by the properly authorized person.

Checks: There should be 2 signatures need for the checks. Only those authorized should be signing checks. All check expenditures should be recorded in the check book ledger and noted with the corresponding check number. Checks should not be signed in advance, and no one should be given a signed blank check.

Bank accounts: Secure records should be kept on all accounts. Regular bank reconciliations should be carried out. Each account's activity should be checked to make sure no accounts are dormant. Bank statements should be reviewed regularly by officers other than the treasurer.

I hope this makes preparing for your audit easier for you. If you keep good records of all your account activity your Audit should be easy peasy.

Great teams of people often have the following things in common: Team members can name and understand the **individual talents** of everyone on the team.

Team members can see a clear connection between each other's strengths and behavior. They can see the link between **strengths** and **success**.

Everyone on the team has partnerships that encourage their strengths development.

Team members use their knowledge of each other's strengths to plan, strategize, analyze and direct their actions.

Do you want your unit or county ALA team to be a great team? Is your unit / County already a great team and do you want to take them to the next level? I would encourage you to learn more about your team's individual strengths, personality attributes, and how they can help your team function in a more cohesive manner. There are several research-based resources that can help you know your team's strengths and weaknesses in a way that can help you support one another when executing events and pursuing opportunities.

Option 1: High Five Test

Leverage what is unique about you to achieve greater results in your professional and personal lives. Then compare these results with those in your team to learn and grow. Take a 120-question test to then get a summary of your results. The basic report is free, but there are options that require a payment if you are interested in getting more detail.

Option 2: The Big 5 Personality Test

The <u>Big Five test</u> is one of the most studied personality tests in psychology. It is the result of many psychologists trying to determine how many "traits" define a person's personality. The "Big Five" stand for Openness, Conscientiousness, Extraversion, Agreeableness, and Neuroticism. Like the Myers Briggs test, each trait has an "opposite" trait. A person may display high agreeableness, for example, and low extraversion.

Once approved, paperwork and amount of grant (up to \$1.200) is submitted to the Department Office so that a check can be dispensed.
