Pursuant to the requirements of the Constitution and Bylaws of the American Legion Auxiliary, Department of New York, Inc.:

I, Kimberly A. Quick, Department President, do hereby call the **104**th **Annual Convention** of the American Legion Auxiliary, Department of New York, Inc. to be held in **Syracuse, New York on July 17**^{th,} **and July 18**th, **2025** to convene at 9:00 a.m. Daylight Saving time on the **17**th day of July for the following purposes.

1. To elect delegates and alternates to the National Convention of the American Legion Auxiliary to be held August $25^{th} - 28^{th}$, 2025 in Tampa, FL.

Proposed Amendment #1 Constitution & Bylaws Footnote: Article XIII, Section 2

Section 2. Membership in The American Legion Auxiliary shall be limited to the grandmothers, mothers, sisters, spouses, and direct and adopted female descendants of members of The American Legion, and to the grandmothers, mothers, sisters, spouses, and direct and adopted female descendants of all men and women who were in the Armed Forces of the United States during any of the following periods: April 6, 1917, to November 11, 1918; and any time after December 7, 1941; or who, being citizens of the United States at the time of their entry therein, served on active duty in the Armed Forces of any government associated with the United States during any of said periods, and died in the line of duty or after honorable discharge; and to those women who of their own right are eligible for membership in The American Legion.

Eligibility for membership in the American Legion Auxiliary includes male and female spouses, parents, grandparents, sisters, and direct and adopted female descendants of members of The American Legion, as well as honorably discharged deceased veterans.

Section 2. Membership in The American Legion Auxiliary shall include grandparents, parents, sisters, male and female spouses, and direct and adopted female descendants of members of The American Legion, as well as honorably discharge deceased veterans and to the grandparents, parents, sisters, male and female spouses, and direct and adopted female descendants of all men and women who were in the Armed Forces of the United States as well as honorably discharged deceased veterans during any of the following periods: April 6, 1917, to November 11, 1918; and any time after December 7, 1941; or who, being citizens of the United States at the time of their entry therein, served on active duty in the Armed Forces of any government associated with the United States during any of said periods, and died in the line of duty or after honorable discharge; and to those women who of their own right are eligible for membership in The American Legion.

If adopted, this resolution be forwarded to the National American Legion Auxiliary organization for consideration.

Proposed by: Unit 468 Cindy Sharick, Eileen Klemz, Helen Eisenberg

Rationale: At present, fathers and grandfathers of American Legion members, as well as honorably discharged deceased veterans or current honorably serving service members, do not have a designated place within the Legion family to join.

DELEGATE AND ALTERNATE INSTRUCTIONS

Per the Department Constitution **ARTICLE VII, DEPARTMENT CONVENTION, SECTIONS 4 and 5:** Each Unit in the Department shall be entitled to one (1) delegate and one (1) alternate for the first ten (10) members and one (1) additional delegate and one (1) additional alternate for each additional one hundred (100) members or major fraction thereof, whose current dues have been paid thirty (30) days prior to the date of the Convention. Unit delegate's entitlements unused by Units may be elected from the respective County's membership at the June County meeting. The immediate Junior Past President of the Unit shall become the first delegate to be elected.

If a <u>Delegate</u> cannot attend for any reason, the highest elected <u>Alternate</u> present would become a <u>Delegate</u> in her/his/their place. (Immediate Past County President is the delegate)
